Case Narrative

On 03-18-2006 at 0400 hours, I, Officer Capece [#12608], responded to 325 South Orange Avenue (Westin Grand Bohemian Hotel) in reference to a trespasser. Upon my arrival, I met with security guard Frank Santiago, who escorted me to the trespasser in room 1015. Once outside room 1015, I made contact with Vanessa Lopez, who was standing outside the room waiting for my arrival. As I escorted Lopez from the hotel, she asked for a police report. I asked her what crime she wanted to report to which she would not answer me, but just insisted on a report. As we exited the hotel, I explained to Lopez that I would be happy to take a report if there was a crime she wanted to report.

Lopez, who was visibly upset and agitated, stated she should not have been treated like that. Lopez stated she was visiting her boyfriend, Delonte West, who plays for the Boston Celtics and who was staying with the team on the 10th floor of the hotel. Lopez stated she has a prior sexual relationship with West and had stayed in the hotel last night. She stated when she came to visit West, he began to address her but she did not want to have that kind of contact with him. Lopez stated no sexual activity occurred in the room. I asked Lopez to complete a sworn written statement, to which she declined at this time. Several more opportunities were presented to Lopez to write a statement which she again declined.

I made contact with West who provided a verbal statement. West stated he was in town to play the Orlando Magic and arrived on 03-16-2006. He stated he does have a sexual relationship with Lopez but she is not his girlfriend. He stated he was on the phone waiting for another female friend (NOI) to arrive at the hotel when Lopez showed up. He stated he was lying on the bed when she

entered the room and he stated he was talking on the phone when Lopez straddled him on the bed. West stated Lopez got upset when he told her he did not want her in the room because shortly another friend was going to visit. West stated Lopez would not get off him so he did place his arms on her hips and then lifted her off of him. West also declined to provide a sworn written statement.

Security guard Santiago stated while waiting for the police to arrive, Lopez stated to him that she wanted a police report done. He asked her if anything had happened in the room, to which she stated no, but she refused to leave until the police arrived.
