The undersigned is informed and believes that:

COUNT 1

On or between February 9, 2007 and February 10, 2007, in the County of Los Angeles, the crime of RESISTING EXECUTIVE OFFICER, in violation of PENAL CODE SECTION 69, a Felony, was committed by ALEX AGUSTO ANGARITA, who did unlawfully attempt by means of threats and violence to deter and prevent DOWNEY, who was then and there an executive officer, from

performing a duty imposed upon such officer by law, and did knowingly resist by the use of force and violence said executive officer in the performance of his/her duty.

COUNT 2

On or between February 9, 2007 and February 10, 2007, in the County of Los Angeles, the crime of RESISTING EXECUTIVE OFFICER, in violation of PENAL CODE SECTION 69, a Felony, was committed by ALEX AGUSTO ANGARITA, who did unlawfully attempt by means of threats and violence to deter and prevent ANDRENO, who was then and there an executive officer, from performing a duty imposed upon such officer by law, and did knowingly resist by the use of force and violence said executive officer in the performance of his/her duty.

On or between February 9, 2007 and February 10, 2007, in the County of Los Angeles, the crime of BATTERY WITH INJURY ON A PEACE OFFICER, in violation of PENAL CODE SECTION 243(c)(2), a Felony, was committed by ALEX AGUSTO ANGARITA, who did unlawfully use force and violence and inflict an injury upon the person of DOWNEY when said defendant(s), ALEX AGUSTO ANGARITA knew and reasonably should have known that said person was a peace officer then and there engaged in the performance of duty.

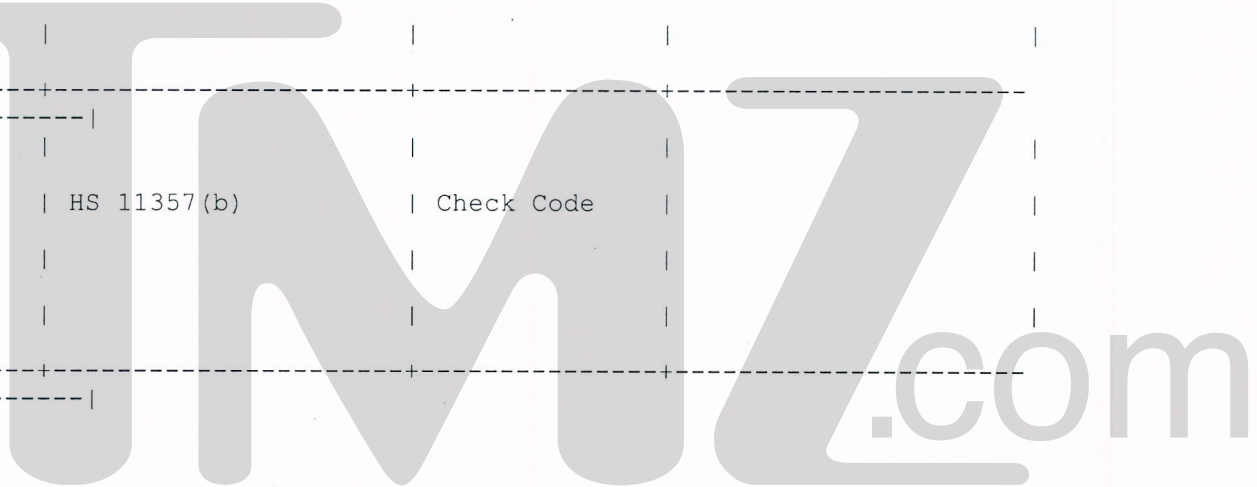
