**FELONY COMPLAINT**

The undersigned is informed and believes that:

COUNT 1

On or about February 12, 2008, in the County of Los Angeles, the crime of DRIVING UNDER THE INFLUENCE OF ALCOHOL OR DRUGS, in violation of VEHICLE CODE SECTION 23152(a), a Misdemeanor, was committed by BARRON NICHOLAS HILTON, who did unlawfully, while under the influence of an alcoholic beverage and a drug and under their combined influence, drive a vehicle.

COUNT 2

On or about February 12, 2008, in the County of Los Angeles, the crime of DRIVING WHILE HAVING A 0.08% OR HIGHER BLOOD ALCOHOL, in violation of VEHICLE CODE SECTION 23152(b), a Misdemeanor, was committed by BARRON NICHOLAS HILTON, who did unlawfully, while having 0.08 percent and more, by weight, of alcohol in the blood, drive a vehicle.

COUNT 3

On or about February 12, 2008, in the County of Los Angeles, the crime of UNLAWFUL USE OF LICENSE, in violation of VEHICLE CODE SECTION 14610(a)(1), a Misdemeanor, was committed by BARRON NICHOLAS HILTON, who did unlawfully display, cause, and permit to be displayed and have in his/her possession a canceled, revoked, suspended, fictitious, and fraudulently altered and obtained driver's license.

COUNT 4

On or about February 12, 2008, in the County of Los Angeles, the crime of UNLICENSED DRIVER, in violation of VEHICLE CODE SECTION 12500(a), a Misdemeanor, was committed by BARRON NICHOLAS HILTON, who did unlawfully drive a motor vehicle upon a highway without holding a valid driver's license issued under the Vehicle Code of the State of California.
