**FELONY COMPLAINT
FOR ARREST WARRANT**

The undersigned is informed and believes that:

COUNT 1

On or about December 2, 2006, in the County of Los Angeles, the crime of VEHICULAR MANSLAUGHTER WITHOUT GROSS NEGLIGENCE, in violation of PENAL CODE SECTION 192(c)(3), a Felony, was committed by LANE EDWARD GARRISON, who did unlawfully and without gross negligence kill VAHAGN SETIAN, a human being, while driving a vehicle in violation of Vehicle Code Sections 23152 and 23153 and in the commission of an unlawful act, not amounting to a felony, to wit, a violation of Vehicle Code Section 22350 and 21658(a) and in the commission of a lawful act which might produce death, in an unlawful manner.

COUNT 2

On or about December 2, 2006, in the County of Los Angeles, the crime of D.U.I. CAUSING INJURY, in violation of VEHICLE CODE SECTION 23153(a), a Felony, was committed by LANE EDWARD GARRISON, who did unlawfully, while under the influence of an alcoholic beverage and a drug and under their combined influence, drive a vehicle and in so driving, concurrently did an act forbidden by law and neglected a duty imposed by law which proximately caused bodily injury to VAHAGN SETIAN, MICHELLE OHANA, CHEN SAGI.

It is further alleged that the defendant, in violation of Vehicle Code section 23558, proximately caused bodily injury and death to VAHAGN SETIAN, MICHELLE OHANA, CHEN SAGI.

It is further alleged that the defendant had a blood alcohol content of .15 percent and more, by weight, within the meaning of Vehicle Code Section 23578.

COUNT 3

On or about December 2, 2006, in the County of Los Angeles, the crime of DRIVING WITH A .08% BLOOD ALCOHOL CAUSING INJURY, in violation of VEHICLE CODE SECTION 23153(b), a Felony, was committed by LANE EDWARD GARRISON, who did unlawfully while having .08 percent and more, by weight, of alcohol in his/her blood, drive a vehicle and in so driving did an act forbidden by law and neglected a duty imposed by law which proximately caused bodily injury to VAHAGN SETIAN, MICHELLE OHANA, CHEN SAGI.

It is further alleged that the defendant, in violation of Vehicle Code section 23558, proximately caused bodily injury and death to VAHAGN SETIAN, MICHELLE OHANA, CHEN SAGI.

It is further alleged that the defendant had a blood alcohol content of .15 percent and more, by weight, within the meaning of Vehicle Code Section 23578.

COUNT 4

On or about December 2, 2006, in the County of Los Angeles, the crime of SALE OF ALCOHOL BEVERAGE TO A MINOR, in violation of BUSINESS & PROFESSIONS CODE SECTION 25658(a), a Misdemeanor, was committed by LANE EDWARD GARRISON, who did unlawfully sell, furnish, give, and cause to be sold, furnished, and given away to VAHAGN SETIAN, a person under the age of eighteen years, an alcoholic beverage, to wit, VODKA, containing more than one-half of one percent of alcohol by volume and fit for beverage purposes.

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and *Cunningham v. California* 2007 U.S. LEXIS 1324.

Further, attached hereto and incorporated herein are official reports and documents of a law enforcement agency which the undersigned believes establish probable cause for the arrest of defendant(s) LANE EDWARD GARRISON for the above-listed crimes. Wherefore, a warrant of arrest is requested for LANE EDWARD GARRISON.

I DECLARE UNDER PENALTY OF PERJURY THAT THE FOREGOING IS TRUE AND CORRECT AND THAT THIS COMPLAINT, CASE NUMBER SA063322, CONSISTS OF 4 COUNT(S).
