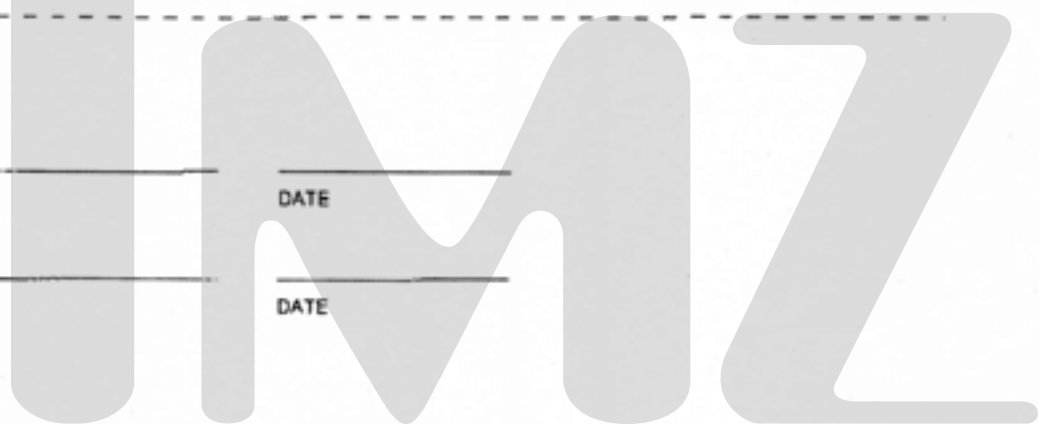

I Deputy Gutierrez, J.W., Being first duly sworn, deposes and says:

1. That he/she is a Deputy Sheriff for the Teton County Sheriff's Department
2. That on the 18th day of October, 2007 he/she initiated a complaint on a uniform citation form against the above named defendant for the crime of 18-8004 A(1) Driving While Under the Influence(Narcotics Refusal), 37-2732 C(3) Possession of a Controlled Substance, and 37-2734 A(1) Possession of Drug Paraphernalia. The report thereof attached hereto and incorporated by reference in this Affidavit sets forth the basis for probable cause for the arrest or bonding of the named defendant.
3. That the following statement is offered as probable cause if no report is attached.

On 10/18/2007 at 2122 hrs, I (Deputy Gutierrez) was patrolling southbound on Hwy 33 when I observed a vehicle that was also southbound on Hwy 33 directly in front of my patrol vehicle. I began to notice the vehicle swerve close to the fog line and then to the center line of the highway. I also observed that the vehicle slowed to 30mph in a 45mph zone. After we entered a 55mph zone after Mile Post 142, the vehicle sped up to the posted speed limit of 55mph. I then observed the vehicle cross over the fog line and again swerve back over to the center line. The vehicle then slowed down to 40mph in a 55mph zone. I then activated my overhead lights and I stopped the vehicle at Mile Post 144. I exited my patrol vehicle and immediately was able to smell a strong odor of burning marijuana. I then approached the vehicle from the driver's side and the odor of the marijuana got stronger the closer I got to the vehicle. As I approached the vehicle I noticed all four window of the vehicle were lowered and the female driver was not wearing a jacket. I asked the female driver if she knew why I had stopped her. She responded that she might have been speeding. I informed that I had not stopped her for her speed. I then informed the driver that I had observed her driving pattern and her

speeding up and then slowing down. I then asked the female driver why I could smell an odor of marijuana coming from within the vehicle. The driver stated that she had given a ride to three hitchhikers and had just dropped them off at the corner of Bates Rd. and Main St. in Driggs. The driver also stated that they had started smoking something and that is when she had dropped them off. I then asked the driver for her driver's license. She produced a California driver's license that identified her as Dawn Elberta Wells born 10/18/1938. I then asked Wells that due to the strong odor of marijuana coming from within the vehicle if I could have her permission to search the vehicle. Wells responded that I had her permission to search the vehicle. I then had Wells exit the vehicle and stand the front her vehicle off of the roadway. I then began to search the vehicle and I found half of a smoked joint in the ashtray of the center console. I then found two more half smoked joints inside the center console. I then paused the search and I informed Wells that I would perform the Standardized Field Sobriety Test's of her to ensure that she was not under the influence of drugs or alcohol. I then had Wells stand with her back to my patrol vehicle and I went to my vehicle and called to Dispatch Wells information and also to have Deputy Hale search for the three hitchhikers on Bates Rd. and Main St. I then turned off my overheads and turned off my take down lights.

I returned to Wells and I asked her if she had had any recent head injuries, back injuries or knee injuries. Wells responded that she had bad knees. I then asked Wells if she was able to walk and stand ok. She responded yes. I then explained the Horizontal Gaze Nystagmus to Wells. I observed that Wells' eyes lacked a smooth pursuit. I also observed the Wells displayed a nystagmus prior to 45 degrees. I performed the test on Wells and I scored her 4 out of 6 on this test. I then explained and demonstrated the Walk and Turn to Wells. During the instruction phase Wells could not keep her balance. Wells also missed heel to toe on several steps, stepped off line and raised her arms for balance. Wells also performed an improper turn. I scored Wells 5 out of 8 on this test. I then explained and demonstrated the One Leg Stand to Wells. I observed Wells sway to keep balance and also raised her arms for balance. Wells also put her foot down during the test. I scored Wells 3 out of 4 on this test. Wells was then taken into custody. I handcuffed Wells checked for tightness and double locked them. I then placed Wells into the back of my patrol car. I then called to Dispatch for a tow truck to tow Well's vehicle. Deputy Hale called in that he had been unable to locate on hitchhikers on Bates Rd. or Little Ave. Deputy Hale then arrived on scene 2200 to assist with an inventory search of Wells' vehicle. During the inventory search there was found two small cases, located in the center console, used to store marijuana and a small ashtray behind the passengers seat containing a fourth half smoked marijuana joint. After the tow truck had arrived I transported Wells to the Teton County Sheriff's Office to be tested. At the Sheriff's Office Wells refused to be tested for any of the Evidentiary Tests. Wells was booked in for 18-8004 A(1) Driving While Under the Influence(narcotics refusal), 37-2732 C(3) Possession of a Controlled Substance and 37-2734 A(1) Possession of Drug Paraphernalia. Wells was explained and given a copy of the Notice of Suspension Form and explained and given copies of her citation. Wells later bonded through Teton Bail Bonds. EOR

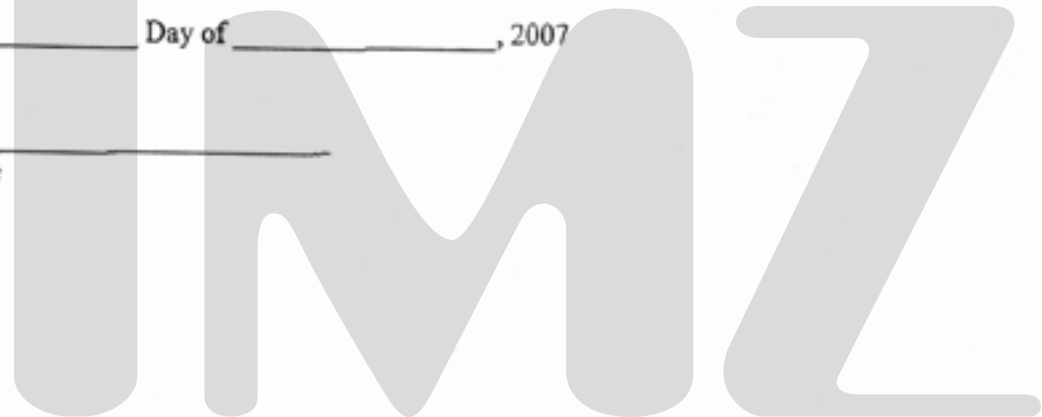
