COUNT 1

On or about March 3, 2008, in the County of Los Angeles, the crime of POSSESSION OF A CONTROLLED SUBSTANCE, in violation of HEALTH & SAFETY CODE SECTION 11350(a), a Felony, was committed by STEPHEN GLOVER, who did unlawfully possess a controlled substance, to wit, cocaine.
