On 04/08/2007 at approx 0032 hours officers responded to a disturbance at the Waterfront Marriott, 2100 Alaskan Way. Upon arrival officers contacted hotel security officer C/V [REDACTED] in the lobby. He stated there had been a disturbance between several people in the hotel. Three of the guests who had been involved in the altercation were still in the lobby. C/V [REDACTED] made contact with them. He found two of the subjects wrestling on the floor. One of the subjects stated he was restraining the other. The subject being restrained was later identified as S/WAHLER. C/V [REDACTED] warned the subjects to stop the disturbances or they would have to leave the hotel. S/WAHLER became hostile with C/V [REDACTED]. He yelled and cursed at the victim. S/WAHLER got into C/V [REDACTED]'s face in a threatening manner and continued to yell at him. C/V [REDACTED] stepped back away from S/WAHLER to get some space between them. At this point S/WAHLER shoved the victim in his chest with both hands. S/WAHLER then used his right fist to punch C/V [REDACTED] in the mouth. An unidentified member of the trio had to physically restrain S/WAHLER and removed him from the hotel. S/WAHLER ran south from the hotel but returned a short time later. Officers located S/WAHLER passed out on the floor in a hallway on the third floor. S/WAHLER was contacted and awakened. He was very intoxicated. There was a strong odor of intoxicants emanating from him and he was very unsteady on his feet. S/WAHLER was taken into custody and escorted out of the hotel. S/WAHLER was highly agitated and hostile. He repeatedly called me "a nigger", "a faggot" and "a poor fuck". S/WAHLER stated he was rich and would have my ass. S/WAHLER made vague threats to assault officers. S/WAHLER said to me, "Come down to LA County and get your ass kicked!" During the entire contact S/WAHLER remained belligerent and hostile. I screened the arrest with Sgt Hancock and S/WAHLER was subsequently booked into KCJ.
