1           WHEREAS, on February 1, 2008 the Probate Department of the Los Angeles Superior  
2 Court (the "Probate Court"), the Honorable Reva Goetz presiding, granted the application of  
3 James P. Spears ("Mr. Spears"), as conservator of the person of Britney Jean Spears and as co-  
4 conservator of the estate of Britney Jean Spears, for a civil harassment temporary restraining  
5 order (the "TRO") against Osama ("Sam") Lutfi ("Mr. Lutfi"), setting the hearing on the  
6 application for February 22, 2008;

7           WHEREAS, on February 14, 2008 the conservatorship proceedings in which the TRO  
8 application was granted were removed to the United States District Court for the Central District  
9 of California (the "Central District");

10           WHEREAS, on February 21, 2008 the Central District, the Honorable Philip S. Gutierrez  
11 presiding, granted Mr. Spears' *ex parte* application to continue the TRO, setting a new hearing  
12 on the TRO application for 1:30 p.m. on March 17, 2008;

13           WHEREAS, on February 26, 2008 the Central District, the Honorable Philip S. Gutierrez  
14 presiding, remanded the case to the Probate Court;

15           WHEREAS, the Probate Court set the hearing on the TRO application for 1:30 p.m. on  
16 March 17, 2008;

17           WHEREAS, on March 17, 2008 the Probate Court, pursuant to a stipulation between the  
18 parties, continued the hearing on the TRO application from March 17, 2008 to 1:30 p.m. on April  
19 16, 2008;

20           WHEREAS, Mr. Lutfi and Mr. Spears are in discussions that may resolve the issues  
21 presented by the TRO application, thereby making a hearing unnecessary; and

22           WHEREAS, the hearing on a permanent conservatorship is currently scheduled for July  
23 31, 2008;

24           IT IS HEREBY STIPULATED that:

25           1.     The hearing on the TRO against Mr. Lutfi may be continued until  
26 1:30 p.m. on July 31, 2008, or such other date and time as may be convenient for
