I was working uniformed patrol in the City of Seattle as one officer unit 3-ROBERT-2. I responded to [redacted] / Av S [redacted] on report of a stabbing. When I entered this apartment, I observed a B/F (later identified as V/S [redacted]) lying on the couch. She had a towel covering her upper chest and it appeared to be covered in blood. [redacted] removed the towel and I could see a stab wound to her upper chest area approximately 1/2 to 3/4 inches in width. Seattle FD then entered the apartment and began providing medical care. [redacted] was transported to HarborView Medical Center for further medical attention. I briefly spoke with [redacted] who lives in [redacted] who stated he was asleep when [redacted] knocked on his door. When he answered the door, he could see [redacted] was bleeding and allowed her to come in and lay down on his couch. [redacted] told [redacted] she was stabbed by [redacted] and that her money was taken. [redacted] stated this occurred downstairs and that three other females were with [redacted] at the time. I then relocated [redacted] where the assault reportedly occurred and searched it for a possible weapon or any other item of evidentiary value. I located a large clump of hair in a garbage can near the kitchen, but did not locate a possible weapon. I was advised by neighbor's that [redacted]. After speaking with the on site manager, it was determined he lived [redacted]. A search of this apartment met with negative results. It was also determined that [redacted] frequents [redacted] located at [redacted] which is close to the scene of the incident. Officers relocated to this address, but were unable to locate [redacted]. The bartender stated [redacted] was a known patron and they would call the police if she came to the bar. I then spoke with [redacted] who stated she was in [redacted] with several people and they were all drinking beer and watching "America's Next Top Model" on the television. [redacted] thought [redacted] was talking too loudly and told her to [redacted]. [redacted] refused to talk quieter, [redacted] walked over and opened her apartment door. [redacted] then told [redacted] to [redacted]. The two continued arguing and [redacted] began punching [redacted] numerous times and pulled out a large clump of [redacted] hair. [redacted] then grabbed a small paring knife that was in an apple nearby and stabbed [redacted] in the chest and the neck during the scuffle. The witnesses were able to separate the two and [redacted] ran into the bedroom. [redacted] had taken the knife away from [redacted] before the two were separated. [redacted] asked if she was stabbed because she saw blood on her shirt. [redacted] then left the apartment and relocated to [redacted]. [redacted] then told [redacted] she stabbed [redacted]. [redacted] stated, [redacted] and they fled the apartment. An extensive area check for [redacted] met with negative results. I took several photographs of apartment [redacted] and forwarded them to evidence.
