The Smith Barney retirement account

The community property portion of the Smith Barney retirement account on line B.11 of the Gurse, Schneider balance sheet, account number ending in 9917, shall be divided equally between the parties by a qualified domestic relations order. Each party shall pay one half the cost of the expense.

All residuals received by the respondent are awarded to the respondent.

The respondent shall pay to pay to the petitioner for the support of the minor child Homer Heche Lafoon, born 3-2-02, the sum of \$3,700.00 per month, payable one-half on the first day and one-half on the fifteenth day of each month, commencing July 1, 2008 and continuing pursuant to Section 3901 of the Family Code.

The minor child's private school tuition shall be paid 75% by the respondent and 25% by the petitioner.

Each party shall pay one-half of any uninsured medical, dental or other medical related expenses.

Each party shall pay one-half of agreed upon extra-curricular activities of the minor child.
