Dear Mr. Campbell and Ms. Pinnock:

We are in receipt of your and Mr. Campbell's March 17, 2008 response to our letter of March 13, 2008 concerning Mr. Tyler Perry.

Our client concurs that Mr. Campbell is in fact his cousin. However, all other matters in the response are untrue, including, without limitation, that Mr. Campbell is/was authorized to distribute any stage plays or any other productions of Mr. Perry.

Mr. Campbell does not have the right to use Mr. Perry's name in the furtherance of Mr. Campbell's endeavors. The use of Mr. Perry's name in connection with the promotion of any projects of Mr. Campbell, you or your agency is intentionally misleading, constitutes a substantial misrepresentation of the facts and wrongfully infringes upon the economic value of Mr. Perry and his products and productions.

We, again, demand that you immediately remove from each press release all references to Mr. Perry, all misleading statements concerning Mr. Perry and that Mr. Campbell was the first distributor, screenwriter of Mr. Perry's films and that you immediately cease and desist from further dissemination and further publication of the press releases containing such untrue and misleading statements, the content of such press releases as the same relate to Mr. Perry and Mr. Campbell's involvement with Mr. Perry's films, and/or the use of the Tyler Perry name and/or image.

We, again, further demand that you cause to be printed an immediate prominent retraction of these false statements, including an acknowledgement that Mr. Perry is not teaming up with Mr. Campbell nor is Mr. Perry involved in any way with the movie, "Oblivious"; that Mr. Campbell is not nor has he ever been a distributor, screenwriter for Mr. Perry; and Pam Pinnock and/or A List Public Relations are not and have never been authorized in any way to release press releases or any other information regarding Mr. Perry or his films. This immediate prominent retraction should appear on www.pr.com as well as on any other sites or places where these false statements appear. Please provide us with a copy of each such retraction and where it appears, along with written confirmation that the false statements pertaining to our client have been removed from the press releases.
