OFFICER WAS DISPATCHED TO A FAMILY PROBLEM WHERE A MALE WAS LOCKED OUT OF HIS RESIDENCE BY HIS WIFE AFTER A FIGHT HAD OCCURRED. OFFICER TRIED TALKING TO HIS WIFE IN THE DRIVEWAY OF THE RESIDENCE TO RESOLVE THE PROBLEM. THE FEMALE YELLED AND CALLED OFFICER "FU ER" AND TOLD OFFICER "FU YOU AND FU HIM" SEVERAL TIMES DURING THE CONVERSATION AND WAS ACTING TUMULTOUSLY AS PEOPLE WERE WALKING PAST ON THE SIDEWALK. OFFICER TOLD HER TO STOP USING THAT LANGUAGE AND TO RELAX, SHE WOULD FOR A MOMENT THEN START THE SAME BEHAVIOR AGAIN. SHE ADMITTED TO OFFICER THAT SHE "THRASHED" HIS BEDROOM WHILE HE WAS OUTSIDE THE HOUSE. OFFICER, WENT INSIDE THE RESIDENCE WITH HER HUSBAND WHO IS THE OWNER OF THE HOUSE, AND OBSERVED HIS BEDROOM WAS DESTROYED. HIS DRESSER WAS TIPPED OVER, THE DRAWERS WERE REMOVED AND THROWN AROUND, HIS CLOTHING WAS THROWN AROUND, HIS DVD STAND AND DVDS WERE TIPPED OVER AND THROWN AROUND. THE SHELVES WERE DAMAGED. AS THE WIFE ENTERED THE ROOM, SHE TOLD HIM "YOU DESERVE THIS AFTER HOW YOU TREATED ME" AND BEGAN CLEANING UP THE ROOM. OFFICER ESCORTED THE FEMALE OUTSIDE. AT THAT TIME, SHE HAD HANDCUFFS PLACED ON HER WRISTS BEHIND HER BACK AND WAS PLACED IN THE BACK SEAT OF MY PATROL CAR.
