It is mutually agreed as follows:

Miscellaneous: rockstarpromote will not use MTV logos or the 'RHM' name in advertising efforts. All promotional material must be approved by Audrina Patridge representative

ACCOMMODATIONS AND TRAVEL: PURCHASER WILL PAY FOR ON TOP OF COMPENSATION THE FOLLOWING AS REQUIRED BY ARTIST: 1 FIRST CLASS SUITE, (4 STARS OR BETTER AND PROVIDE FIRST CLASS EXCLUSIVE GROUND TRANSPORTATION TO AND FROM SAN DIEGO AND VENUE FOR ARTIST(S) IN LOS ANGELES AND SAN DIEGO. PURCHASER WILL ALSO PROVIDE A SECURE VIP AREA WITH COMPLIMENTARY BEER, MIXED DRINKS, AND BOTTLE SERVICE (2 BOTTLES), AND AT LEAST ONE SECURITY GUARD AT ALL TIMES. ALL TRAVEL SHALL BE TO AND FROM ARTIST'S AND GUEST'S THEN CURRENT LOCATION.

CANCELLATIONS: (A) THE PARTIES MAY NOT CANCEL THE APPEARANCE FOR ANY REASON, EXCEPT IF THE APPEARANCE IS PREVENTED OR MATERIALLY IMPAIRED FOR REASONS OF AN ACT OF GOD, NATURAL DISASTER, CATASTROPHE, ACCIDENT, FIRE, LABOR DISPUTE, LOCKOUT, STRIKE, RIOT OR CIVIL COMMOION, ACT OF PUBLIC ENEMY, GOVERNMENTAL ACT, REGULATION OF RULE, FAILURE OF TECHNICAL FACILITIES, ARTIST'S ILLNESS OR OTHER SIMILAR CIRCUMSTANCE OR EVENT BEYOND THE CONTROL OF ARTIST(S) ("FORCE MAJEURE") OR FOR FILM AND/OR TELEVISION WORK COMMITMENTS BY ARTIST(S). IF ARTIST(S) CANCELS DUE TO FILM OR TELEVISION WORK, ARTIST(S) SHALL HAVE THE OPTION TO RESCHEDULE EVENT ACCORDING TO PURCHASER'S AND ARTIST(S) SCHEDULE OR REFUND THE ENTIRE DEPOSIT. IF THE APPEARANCE IS CANCELLED DUE TO FORCE MAJEURE, THE PARTIES SHALL RESCHEDULE THE EVENT ACCORDING TO THE PURCHASER'S AND ARTIST'S SCHEDULE OR REFUND THE ENTIRE DEPOSIT.

(B) IF DATE IS CANCELLED BY PRODUCER & ARTIST FOR ANY OTHER REASONS OUTSIDE FILM AND/OR TELEVISION WORK COMMITMENTS OR FORCE MAJEURE, ANY MONIES, DEPOSITS, ETC. SENT WILL BE RETURNED WITHIN THIRTY DAYS AND PRODUCER & ARTIST SHALL BE RESPONSIBLE FOR REIMBURSING PURCHASER FOR ANY REASONABLE OUT OF POCKET EXPENSES ACTUALLY INCURRED SPECIFICALLY NON-REFUNDABLE AND/OR NON-EXCHANGEABLE FLIGHTS AND HOTEL ROOMS.

(C) PURCHASER AGREES THAT IF PURCHASER CANCELS THE APPEARANCE FOR ANY REASON BEFORE APPEARANCE DATE, THE DEPOSIT IS FORFEITED IN FULL.

LIABILITY: IN NO EVENT SHALL ROCKSTARPROMOTE BE LIABLE FOR THE LOSS OF PROFIT OR OTHER SIMILAR OR DISSIMILAR COLLATERAL OF CONSEQUENTIAL DAMAGES, WHETHER BASED ON BREACH OF CONTRACT, WARRANTY OR OTHERWISE. PURCHASER AND BOOKING AGENT SHALL JOINTLY AND SEVERALLY INDEMNIFY, DEFEND AND HOLD PRODUCER AND ARTIST (AND ANY GUEST OR INVITEE OF ARTIST) HARMLESS FROM AND AGAINST ANY AND ALL LIABILITIES, JUDGMENTS, CLAIMS, COSTS, DAMAGES, LOSSES AND EXPENSES (INCLUDING WITHOUT LIMITATION COSTS AND REASONABLE OUTSIDE ATTORNEYS' FEES AND COURT COSTS, WHETHER OR NOT IN CONNECTION WITH LITIGATION), JUDGMENTS OR PENALTIES ARISING OUT OF OR IN CONNECTION WITH THE APPEARANCE AND/OR ARTIST'S SERVICES HEREUNDER.
