Amended Misdemeanor Complaint

Count 1

On or about December 16, 2006, in the above named Judicial District, the crime of DRIVING UNDER THE INFLUENCE OF ALCOHOL, in violation of Vehicle Code 23152(a), a Misdemeanor, was committed by BROOKE ASHLEY BRINSON, who did unlawfully, while under the influence of an alcoholic beverage, drive a vehicle.

It is further alleged that the defendant had a blood alcohol content of .15 percent and higher within the meaning of Vehicle code section 23578.

Count 2

On or about December 16, 2006, in the above named Judicial District, the crime of DRIVING WHILE HAVING A 0.08% OR HIGHER BLOOD ALCOHOL, in violation of Vehicle Code 23152(b), a Misdemeanor, was committed by BROOKE ASHLEY BRINSON, who did unlawfully, while having 0.08 percent and more, by weight, of alcohol in his/her blood, drive a vehicle.

It is further alleged that the defendant had a blood alcohol content of .15 percent and higher within the meaning of Vehicle code section 23578.


Count 3

On or about December 16, 2006, in the above named Judicial District, the crime of UNLAWFUL USE OF LICENSE, in violation of Vehicle Code 14610(a)(1), a Misdemeanor, was committed by BROOKE ASHLEY BRINSON, who did unlawfully display, cause, and permit to be displayed and have in his/her possession a canceled, revoked, suspended, fictitious, and fraudulently altered and obtained driver's license.
