Ofc Smith and I (Ofc R DeSouza) were dispatched to [REDACTED] in reference to a domestic dispute. Upon arrival, we met the victim, Michael Mosny, sitting on the porch. We conducted the listed interview (see statement). The Officers arriving before us had separated the parties from each other by sight and hearing.

I observed the victim to have no physical injuries, marks, or scratches on his body. His demeanor was calm and very friendly.

Ofc Cholnik read the defendant, Stephanie Clifford, her Miranda warning from the SAO card.

Ofc Smith interviewed the victim and the defendant.

The defendant, Stephanie Clifford who was still on the scene had no injuries and appeared to be very angry.

At the scene, I observed what appeared to be a broken plate, brown in color on the dining room floor. I also observed a flower plant on the window sill without any flower pot. There were two candles on the living room floor with what appeared to be broken shades (glass).

The victim wrote a sworn statement and signed it. The defendant refused to write a statement saying "my lawyer told me never sign any papers and since am paying him a lot of money I will not sign it".

The defendant was arrested and transported to Central Booking.

Ofc Smith photographed the scene, victim and defendant using a 5 megapixel digital camera. The photos were down loaded via MDT, burned to a CD and forwarded to the TPD ID Section.

The victim was given a DV pamphlet regarding his rights and instructions on how to obtain an injunction if he so chooses.

We gave the victim a TPD event number and advised him to contact District One or 911 if anything further develops in this case.

A copy of the victim sworn statement was placed into property for future court proceedings and a copy was forwarded to records.

No further leads at this time.

been paid. Stephine threw a potted plant at the kitchen sink, which was away from Michael. Stephine then hit Michael on his head with her hands several times. Michael stood there. When Stephine was done hitting him he walked into the living-room and sat down. Stephine came into the living-room and threw their wedding album onto the floor and knocked candles off coffee table, breaking them. Michael was not injured.

Post Miranda, Stephanie Clifford advised that she got upset because the way the laundry had been done. She opened some mail and discovered her husband, Michael, had not paid a bill that she had given him money to pay. Now their bank account was frozen. She threw the potted plant at the sink and knocked blankets of the kitchen counter onto the floor. She wanted to leave and Michael had the car keys. She doesn't remember the details of how she attempted to get the keys from Michael but she did not intentional hit Michael. He may have been struck by her hand while she was trying to get the keys he was holding over his head. Stephanie followed Michael into the living room. Still upset she threw their wedding album on the floor and knocked the candles of of the coffee table, breaking the candles. Michael did not hit her and she was not injured.
