**COUNT 1**

On or about June 29, 2008, in the County of Los Angeles, the crime of POSSESSION OF A CONTROLLED SUBSTANCE, in violation of HEALTH & SAFETY CODE SECTION 11377(a), a Felony, was committed by CRAIG PHILLIP ROBINSON, who did unlawfully possess a controlled substance, to wit, MDMA. ### COUNT 3

On or about June 29, 2008, in the County of Los Angeles, the crime of UNDER INFLUENCE OF A CONTROLLED SUBSTANCE, in violation of HEALTH & SAFETY CODE SECTION 11550(a), a Misdemeanor, was committed by CRAIG PHILLIP ROBINSON, who did unlawfully use and be under the influence of a controlled substance, to wit, AMPHETAMINES, COCAINE and CANNABINOIDS.

"NOTICE: Conviction of this offense will require you to register pursuant to Health and Safety Code section 11590. Failure to do so is a crime pursuant to Health and Safety Code section 11594."
