DETAILS:

On August 27, 2008, at approximately 0639 hours, I, Officer D. Walker, P#8533, and Officer D. Swanson, P#9701, acting as marked patrol unit 1P12, were dispatched to a call for service at Spring Mountain/Polaris reference a black male adult in the act of beating a black female adult.

Upon arrival at 3280 Spring Mountain Road, I observed a large-frame, black male adult, wearing a long-sleeve, white, button-up shirt with dark blue jeans, identified as Knight, first name Marion, ID #0915915, punching a black female adult who was undressed from the neck down, lying on the ground, identified as Isaac, first name Melissa, date of birth 10/18/82. I ran over to Knight with my electronic-control device pointed at him. As I and Officer Swanson got within approximately ten feet of Knight, Officer Swanson observed a small, two-inch, wood-handle pocketknife that was open in Knight's left hand as Knight stood over Isaac. Upon giving Knight commands to drop the knife, he complied but refused at first to be proned out on the ground so that he could be taken into custody by officers. After several attempts, Knight complied and was taken into custody.

Upon speaking with Isaac, she stated that the two had been dating for approximately three years. Isaac stated that the two were in the process of entering Spearmint Rhino, an adult-entertainment club, when Knight received a call from another female. Isaac states that when she confronted him, Knight grabbed her hair, this being done while Knight was driving his late-model Cadillac Escalade westbound on Spring Mountain. Isaac states that Knight continued to pull her hair and then began to punch her at the back of her neck area with his right closed fist. Isaac stated that at this point she grabbed the steering wheel hoping to wreck the vehicle so that she could escape him. In doing so the vehicle sustained a flat tire at the passenger's right-front tire area. Knight immediately pulled the vehicle into the parking lot of

Isaac stated that at this point she opened the passenger-front door and attempted to run away from Knight. Isaac states that Knight caught up to her and tossed her to the ground. Isaac states that Knight repeatedly kicked and punched her at the back of her head area. Isaac states that she blacked out and didn't know where she was, and that when she realized where she was, she was getting dragged by her hair by Knight, and she was completely undressed from the neck down, being dragged across the gravel at the location of her injuries. Isaac was transported to Spring Valley Hospital as a result

Knight was read Miranda at approximately 0739 hours by Officer Swanson, and he replied that he understood by saying, "Yes." Upon being searched at the Clark County Detention Center by corrections officers, a small, blue tablet with a Playboy bunny symbol imprinted on one side of it was recovered from Knight's right-front coin pocket. From my training and experience, that blue tablet resembles that of the narcotic known as Ecstasy. Furthermore, two, oval-size, yellow-in-color tablets were also recovered from Knight's front-right pocket. The two, oval-size pills were later identified as 325-milligram Hydrocodone tablets, which is a schedule-three narcotic. Knight had no prescription bottle on his person nor in the vehicle in his name for the Hydrocodone. Knight stated that he had a prescription for the

Hydrocodone, and the prescription was for headaches that he repeatedly had. Knight also informed officers that the Ecstasy table that he had belonged to Isaac and that he was holding it for her.

Due to the above facts and circumstances, Knight was placed under arrest. Knight was transported to CCDC and booked in accordingly.
