I, Rob Lowe, hereby declare that:

1. I am a party to the above-captioned litigation. I have personal knowledge of the matters stated herein and if called as a witness and sworn, I could competently testify thereto.

2. I understand that a former nanny to my children, Laura Boyce, is claiming that she has filed a sexual harassment lawsuit against me. Attached as Exhibit A is a true and correct copy of an "urgent advisory" that I received on or about April 30 that was sent to "citynews@pacbell.net" which states in all caps: "SECOND NANNY SUES ROB LOWE".

3. I have reviewed the allegations in Ms. Boyce's Cross-Complaint and I did not find any allegation in which she alleges I harassed her. Any such allegations would be false as I have never harassed Ms. Boyce or any other employee.

4. Shortly after March 26, 2008, I learned that another former nanny, Jessica Gibson, alleges that I sexually harassed when I received a letter dated March 26, 2008 from her former attorney, John Richards.

5. Shortly after receiving the March 26, 2008 letter, my wife and I contacted our attorney, Stanton L. Stein, Esq., and provided him with a copy of it.

6. I have never acted inappropriately with Ms. Gibson or Ms. Boyce.

7. Since Ms. Boyce, through her attorney, began announcing that a "second nanny" was suing me for sexual harassment, my wife and I have incurred, and will continue to incur, considerable expenses in lawyers' fees and costs, employee time spent reviewing personnel files and gathering material in connection with the lawsuit.

8. Also, since the headline that a "second nanny" sued me for sexual harassment, I have been passed over for at least three commercials, any of which could have ultimately resulted in income of over \$1,000,000.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
