STIPULATION RE PENDENTE LITE  
SPOUSAL SUPPORT; AND ORDER  
THEREON

20 IT IS HEREBY STIPULATED by and between Petitioner, BRITNEY SPEARS,  
21 individually, and by and through her attorneys of record, Wasser, Cooperman & Carter, P.C.  
22 by Laura A. Wasser, and Respondent, KEVIN FEDERLINE, individually, and by and through

24 1. Petitioner shall pay to Respondent as and for non-modifiable pendente lite
