Synopsis Of Events

On November 9, 2007, a S Shannon and her twin sister, Kristina C Shannon got into a physical altercation. Karissa was ultimately arrested for one count of misdemeanor domestic battery.

Source Of Activity

I was dispatched to a disturbance call.

Investigation

Upon arrival, units located a white female, later identified as Kristina C Shannon, laying on the ground outside apartment number 323. She was wearing only blue jean pants. She was bleeding from her nose, as well as several superficial cuts on her hands. She was crying uncontrollably, and making very little sense, shouting at her sister, and asking why she had done this to her.

Standing above her was another white female, later identified as her identical twin sister, Karissa C Shannon. Shannon was asking her who had done this to her, as if she had no idea what had happened. Officers separated all parties and began collecting information.

Narrative - Continued

I first spoke to Celeste M Pullen. Pullen states she is the girl's aunt, and claimed she did not completely understand what had happened, but was told Kristina had gone "crazy" after drinking too much alcohol, and had ended up in a fight with her sister at an unknown named bar on Clearwater Beach. She states she was not out with the girls on this evening, and could not state exactly what had happened, but did states the sisters were in a physical altercation.

I then spoke to Karissa, the arrested in this case. Karissa claimed she and her sister were out on this evening with Kristina's date, O'Neil S. Brown. She claims her sister had too much to drink, and began hitting both of them on the drive home from the beach. She claimed her sister began kicking the windshield of the vehicle from the inside somewhere near the intersection of Drew Street and Belcher Road. She claims they stopped at that intersection and made her get out of the car because of the way she was acting. She showed me bite marks and scratches done to her at this intersection. She then claimed she never saw her sister again until we knocked on the door and she found her sister on the ground, half naked and beaten up. She claimed she did not know who did it to her.

At this point in the investigation I was approached by Timothy M Galvin, an independent witness and neighbor. Galvin stated that he was woken up by the commotion going on outside of his apartment, and exited his apartment from the rear door. He claims he turned the corner and looked up the stairs where he saw the victim on the ground, and her twin sister standing over her kicking her in the face. He stated that at no time did he see anyone else striking the victim, and, although he could not identify which sister was which, was able to identify the two fighting as the twin sisters that live on the second floor of the apartment.

I went back and read Karissa her Miranda Rights Karissa stated that she understood her rights, and wanted to speak to me regarding the fight. She now stated that it was her and her sister fighting, but that it was her sister that had started it because of her intoxication level, and stated she was only defending herself. She showed me several fresh injuries that she stated her sister did to her, and claimed it was a mutual combat which had occurred.

Karissa was charged with a single count of domestic battery on Kristina. Officer Marshal arrived on scene and took photographs of both the victim, and the arrested as well as photos of the scene. Karissa was transported to The Pinellas County Jail without incident.
