ON 10/21/2007 AT 0525HRS, OFC. WILLIAMS BADGE 2622 AND OFC. LYONS#2649 WERE DISPATCHED TO A FIGHT CALL AT 2812 BUFORD HWY (WAFFLE HOUSE RESTAURANT). UPON THEIR ARRIVAL TO THE SCENE, THEY WERE TOLD BY SEVERAL WITNESSES AND EMPLOYEES OF THE WAFFLE HOUSE THAT SEVERAL SUSPECTS ASSAULTED A MAN INSIDE THE WAFFLE HOUSE AND FLED THE SCENE IN A TOUR BUS. OFC. WILLIAMS AND OFC. LYONS WERE ABLE TO MAINTAIN A CLEAR VIEW OF THE TOUR BUS AND STOP THE BUS JUST OVER A HALF MILE SOUTH OF THE WAFFLE HOUSE. OFC. LYONS AND OFC. WILLIAMS WERE ABLE TO IDENTIFY THE SUSPECTS BASED ON THE WITNESSES DESCRIPTIONS.

□UPON MY ARRIVAL TO THE SCENE I SPOKE WITH THE VICTIM MR. AKINS WHO STATED THAT HE WAS ASSAULTED BY SEVERAL MALES INSIDE THE RESTAURANT. BASED ON THE STATEMENT OF THE VICTIM AND OF SEVERAL WITNESSES THE FOLLOWING OCCURRED. MR. AKINS STATED THAT HE WAS SITTING IN A BOOTH INSIDE THE WAFFLE HOUSE, WHEN HE SAW SEVERAL SUSPECTS ENTER THE RESTAURANT. MR. AKINS RECOGNIZED MS. BARNES AND CALLED OUT TO HER. MS. BARNES IGNORED MR AKINS AND CONTINUED TO WALK. MR. AKINS ENGAGED MS. BARNES IN A VERBAL ALTERCATION. SOON AFTER THE SUSPECTS SURROUNDED MR. AKINS AND INITIATED A PHYSICAL ALTERCATION. ONE OF THE SUSPECTS PHYSICALLY REMOVED MR. AKINS FROM THE RESTAURANT. MR. AKINS BEGAN SCREAMING TO CALL THE POLICE, AND AS HE DID ONE OF THE BLACK MALE HEAVY SET SUSPECT STILL INSIDE THE WAFFLE HOUSE USED A METAL DINNING CHAIR TO BREAK A GLASS WINDOW. MR. AKINS ATTEMPTED TO RUN FROM THE SCENE BUT THE SUSPECTS FOLLOWED HIM OUTSIDE AND CONTINUED TO PHYSICALLY HARM MR. AKINS. MR. AKINS WAS STRUCK SEVERAL TIMES WITH THE METAL DINNING CHAIR WHICH WAS LEFT AT THE SCENE OUTSIDE THE RESTAURANT. MR. AKINS WAS TRANSPORTED TO GRADY HOSPITAL BY EMS #12.

□DETECTIVE BAILEY #938 AND DETECTIVE WALKER #926 OF CID RESPONDED TO THE SCENE AND CONTINUED THE INVESTIGATION. INVESTIGATOR JOHNSON #952 OF CRIME SCENE UNIT TOOK PICTURES OF THE SCENE AND COLLECTED THE ITEMS ASSIGNED AS EVIDENCE. THERE IS ALSO VIDEO OF THE INCIDENT.
