

1 SUPPLEMENTAL DECLARATION OF JUSTIN TIMBERLAKE

3 I, JUSTIN TIMBERLAKE, declare as follows:

4 1. The facts stated herein are stated of my own personal knowledge and, if called and
5 sworn as a witness, I could and would testify competently thereto.

6 2. I am a professional recording artist and performer, record producer and actor. I
7 am the petitioner in the captioned action.

8 3. This supplemental declaration is submitted in support of my request for an Order
9 to Stop Harassment against Karen McNeil, and supplements my prior sworn signed declaration
10 by my submission of the application form CH-100 titled "Request for Orders to Stop
11 Harassment", filed October 23, 2009, and my statements and the facts contained in the
12 incorporated Attachment "A" thereto (collectively, the "Request for Orders to Stop Harassment").

13 4. As set forth in my Request for Orders to Stop Harassment, I do not personally
14 know nor have any relationship with a Karen McNeil, nor do I desire any interaction with her
15 what-so-ever. I have never invited her to my property, nor has she ever been given permission
16 to enter my property or home. Despite these facts, Ms. McNeil has, over the course of many
17 months, sought to have personal contact with me and insert herself into my life. I am aware that
18 she has repeatedly shown up uninvited at my place of residence, going so far as to ignore the gate
19 and security fence surrounding my property, by-passing the security entrance, trespassing on my
20 property and hiking down on my property to my home, and gaining entry into my home without
21 my knowledge or permission. I am further aware that, even after the issuance of the TRO in this
22 action, she has continued to try to have contact with me.

23 5. Due to the Ms. McNeil's increasingly harassing, stalking and threatening conduct,
24 some of which is set forth in my Request for Orders to Stop Harassment and, in particular, the
25 Attachment "A" thereto, and the Supplemental Declarations and Exhibits in Support of my
26 Application for Orders to Stop Harassment, and, in particular, the attached Exhibits to the
27 declarations thereto, I have been subjected to a willful course of conduct which has and is
28 seriously alarming, annoying and harassing me.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.


