NARRATIVE	

While on patrol I observed a white pickup, occupied by two, northbound on Euclid approaching Grant Rd that did not have a license plate affixed to the rear bumper area. The license plate was affixed to the rear window and was not clearly visible to me. The truck made a turn westbound on to Grant Rd and while in the median lane made an improper right turn across one lane of traffic into the parking lot located at 605 E Grant Rd. I initiated a traffic stop at 605 E Grant Rd and the truck continued through the parking lot coming to a stop at 555 E Grant Rd. The truck's license plate was out of California. While pulling into a parking space, the truck struck an unoccupied parked vehicle in the rear driver bumper area.

I made contact with the driver, Caleb Wilson (01 88), and spoke with him at my patrol vehicle. Wilson said he had not been drinking any alcohol and was just on his way to get cigarettes. Wilson did not have a current Arizona Drivers License and told me that he has been living in Arizona for, "over a year and a half." Wilson said the truck belonged to his roommate, after failing to show adequate insurance for the vehicle. I explained the infractions to Wilson and he was issued a citation for Improper Right Turn, Failing to Obtain Arizona Drivers License and No Proof Insurance. Ofc. Bouchard (#15628) administered a Portable Breath Test on Wilson with negative results.

Ofc. Thomas (#26732) made contact with the passenger, Katie Cassidy (11 86) who was showing signs and symptoms of alcohol intoxication. Ofc. Bouchard administered a Portable Breath Test with positive results and Cassidy was arrested and field released for Minor in Possession of Alcohol and Giving False Information to Police. This interaction and arrest information has been documented in a supplemental case report.

I made contact with the owner of the parked vehicle that was struck by the truck Wilson was driving. said she was inside work at " " located at E Grant and a co-worker informed her that her vehicle had been struck. I gave the insurance information and agent contact number for the truck's Insurance. Wilson also wanted her to have his name and cell phone number and I facilitated that exchange of information. Wilson then left the scene with Cassidy. NFI.

NARRATIVE

Officer Hayes and I were at NB approaching Grant/1st—a large white pick up truck pulled out from a stop sign at Euclid/1st Ave. There was no plate on the rear bumper of the truck and the truck matched the description of vehicles commonly stolen in the area. We followed the vehicle to the intersection of Grant/ 1st—it drove into the right lane and set up to turn EB. Just prior to the intersection it suddenly pulled across 3 lanes of traffic and went WB on Grant in the median lane of traffic. We were immediately behind the truck when the turn signal came on and it made an immediate right turn, across the curb lane of traffic, into the parking lot of 555 E Grant. We followed the truck and Officer Hayes attempted to effect a traffic stop on the truck by activating the overhead lights.

The truck continued north in the lot, drove to the end of the parking aisle, made another left, drove the distance of 2 more parking aisles, and turned left again. The vehicle was now going SB in the lot—it drove the distance of approx. 4 more parking spaces and then made a hard right into a space, striking the parked/unoccupied vehicle next to it. Officer Hayes made contact with the driver. I went to the passenger side of the truck, on the passenger side of the parked/struck vehicle. That was as close as I could get to it due to the proximity of the truck to the car. The passenger was sitting in the passenger seat, staring straight ahead. I went around to the driver's side and made contact with her. She was dressed in jeans and a blue t-shirt [redacted] on the front.

I noted that the inside of the truck smelled strongly of a sweet alcohol odor. I asked the passenger if she had identification. She said that she did not have anything with her, and that she was from Vancouver. She said, "I can give you my name". I noted that her face was fairly expressionless. Her movements were clumsy and slow. Her thought process seemed to lag. All of the signs and symptoms that I observed were consistent with alcohol consumption. She gave me her name - I had to ask her twice, because her speech was slurred. She told me her name was "Taylor Quinn Cole". I had her spell "Cole" for me, so that I was sure that I had it right as I wrote it down. When I asked her for her birthday she said "I'm 21". I asked her again for her birthday and she said "4-29-84". That birthday would have made her 23 years old. I verified it with her—she said again "I'm 21". I told her that the birthday was in conflict with the age she gave me—she said, "Ok, Ok, I lied to you—that wasn't my real name, but I'll give it to you now."

She then gave me the name of Katie Cassidy DOB 11 -86—with that birthday, she would have been 20. She said that sometimes she uses her step fathers name of [redacted]—She said that he is an ER doctor in California. I had her get out of the truck—we went to the front of my police car. I noted that there was a strong odor of alcohol coming from her breath. I read her Miranda at 0220 "yes" and "yes"—she said that she was scared and that was why she lied. She said that she is a Hollywood actress and that this would not look good for her. She said that she knew that the drinking age was 21 and that she was only 20. She told me that she had consumed "several glasses of wine" and had also consumed some "cranberry and vodka" tonight.

I advised her that she was under arrest for giving me false information. I called for another officer to respond with a PBT. Officer Bouchard responded—I set up the machine and the subject agreed to blow into the machine—initially, she wasn't blowing into the machine, so there was no reading. I explained to her that she needed to push air from her lungs and into the machine. Officer Bouchard administered the test and at 0235 hours the reading was [redacted]. The subject asked me if I would retrieve her sweater from the inside of the truck—I entered the truck from the driver's door and leaned across the truck, looking for the sweater. I saw a red plastic party cup, leaned against the passenger door—it had handwritten, in marker, the words [redacted] on it. There was some red liquid in it—I then saw ice cubes, floating in the door pocket of the truck. They were floating in the same red liquid that was in the cup. I

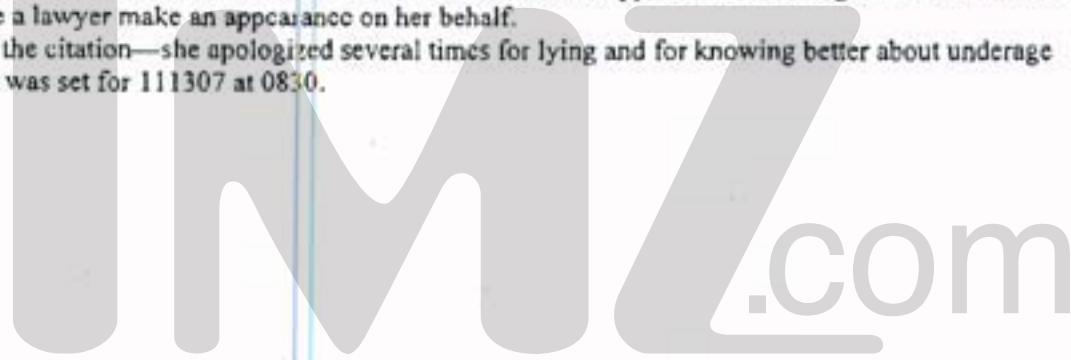

took the cup back to my patrol car and set it on the hood—Cassidy looked at it and shook her head. I asked if it was hers and she said no—she said that she had been holding it for the driver. (The driver had also submitted to the PBT and blew . Cassidy said that the liquid in the cup was cranberry juice and vodka.

I told Cassidy that unless I could verify her identity, I would have no choice but to book her on the charges. She gave me 3 different telephone numbers – a home number for her mother, , a cell for her mother and a cell for her stepfather. She said that it was ok to discuss the case with her mother or stepfather.

I made contact with her mother via my cell phone. I explained the situation to her and asked her to verify the identity of her daughter—she was able to give me an accurate physical description and a matching DOB. I answered her questions as best I could and I even let her talk to Cassidy. The phone call lasted 19 minutes. I told her that I had to go, so that I could finish paperwork and conclude the investigation. I told her that I would have Cassidy call her when we were done. She wanted to know "what could be done" since Cassidy is a "high profile" actress. I told her that Cassidy would need to make an appearance in City Court on the listed charges. She said that Cassidy didn't have time to come back to go to court—I told her that she would need to make an appearance if she signed the citation. She said that she would have a lawyer make an appearance on her behalf.

I issued Cassidy the citation—she apologized several times for lying and for knowing better about underage drinking. Her court date was set for 111307 at 0830.
