[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

CAD INCIDENT DISPOSITION CODE: [2014] [B] [1] [OI]

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 19th day of November, 2007, at approximately 2:30 A.M. P.M. at 4015 Lewis Speedway within St. Johns County, violated the law and did then and there:

I was contacted via page to contact A. Pyle at [REDACTED]. I talked to A. Pyle approximately 20 minutes that evening about his registration requirements. I talked to A. Pyle about his address he listed on his driver's license as 7020 Charles St. A. Pyle told me he let that address ride because he travels a lot, and did not want to put his son's address in North Carolina because he does not want people bothering him about his past. A. Pyle was advised several times during this conversation to register as a Sexual offender in the State he would be residing in with the proper address. A. Pyle stated he would and advised he understood the importance of the registration. I also talked to A. Pyle again on 11/13/2007, via phone who advised me he was coming to see me in on 11/19/2007. A. Pyle since 11/7/2007, has failed to change his address from 7020 Charles St to an address where he resides, which is unknown at this time.

I made contact with the tenants of 7020 Charles St, J. Johnstone who advised me that A. Pyle does not live at his residence. J. Johnstone advised there is no Sexual offenders that live at his residence. Affidavit was obtained, see ccr#07OFF019605.

I also made contact with Det. Mumms of Buncombe County Sheriff's Office in North Carolina, and she made contact with A. Pyle via phone, and he advised her he was living in Florida. Det. Mumms sent a fax letter based on her

conversation and dealings with A. Pyle.

Based on the information above A. Pyle has failed to register his proper address within 48 hours as required by Florida law for all registered Sexual Offenders. A. Pyle came to the sheriff's office on 11/19/2007, and was arrested based on these facts. Det. Brantley and I also conducted an updated registration for the State of Florida and had A. Pyle sign a new notice of responsibilities form. Since this registration, A. Pyle has not registered in anywhere in the United States for approximately five (5) years, avoiding registration because he says he travels a lot throughout the United States.
