## DECLARATION OF DEREK FISHER

I, Derek Fisher, declare as follows:

1. I do not know and am not personally acquainted with Symone Fisher, and I have no desire to have any contact with her. Nonetheless, Symone Fisher has been harassing and stalking me.

2. Without a restraining order, I fear that there will not be sufficient law enforcement mechanisms in place to keep Symone Fisher away from me, or those around me, especially since:

(a) Symone Fisher is apparently mentally ill, and, although she has never met me, believes that we are married and engaged in an active and ongoing relationship; (b) Symone Fisher has repeatedly expressed anger and hostility towards me and my family in her unsolicited written communications; (c) Symone Fisher has demonstrated a willingness to act upon her delusions, repeatedly attempting to contact me and recently showing up, uninvited and unwanted, at my place of work; and (d) Symone Fisher has discovered the street address of my private residence, and has been traveling to and spending time near and around my private residence. Given this harassing and stalking behavior, I believe that any sort of further escalation at this point would put me and my family in danger.

3. The history of Symone Fisher's obsessive, harassing, and stalking behavior is detailed in the declaration of Duran McGregor. Mr. McGregor is the founder and president of McGregor Protection Agency, and has provided me with personal security as well as threat assessment and management services for the past twelve years.


3. I do not want, and have never wanted, to be contacted by Symone Fisher. I have no interest whatsoever in seeing her or communicating with her. Her repeated attempts to contact me, her delusional notions that we are married, her angry and hostile tirades against me, her

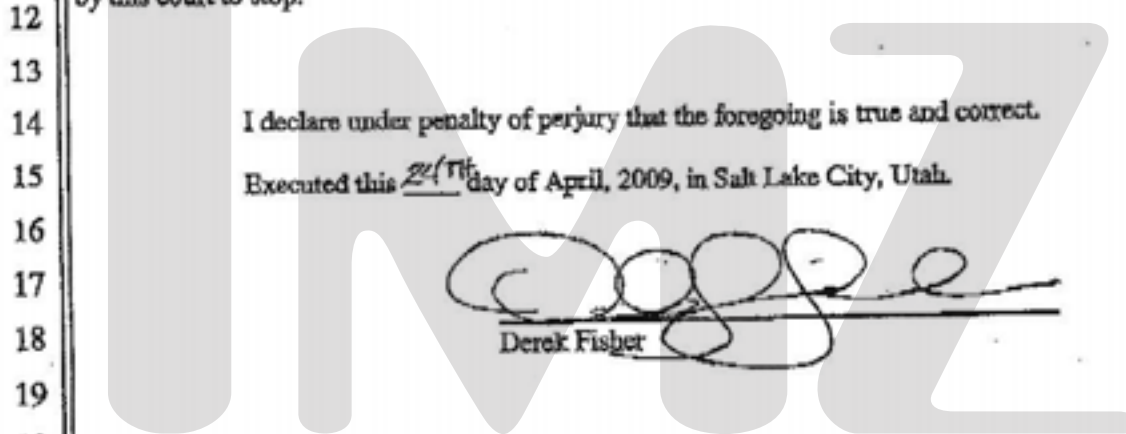
1 appearance at my place of work, and her recent travels near and around my place of residence are  
 2 all extremely frightening to me. I now fear not only for my own safety, but also for the safety of  
 3 those that I care about and love most, including my wife and four children. Indeed, as a result of  
 4 Symone Fisher's behavior, I have been forced to take additional security measures, temporarily  
 5 hiring armed guards to watch over and protect my private residence. In short, I have suffered,  
 6 and continue to suffer, substantial emotional distress as a result of Symone Fisher's behavior.

8 4. I believe, based upon Symone Fisher's obsessive, harassing, and stalking  
 9 behavior that I, and those I love and care about most, are in danger. I believe Symone Fisher will  
 10 continue to engage in this behavior, and that this behavior will continue to escalate, until ordered  
 11 by this court to stop.

14 I declare under penalty of perjury that the foregoing is true and correct.
